# Final Construction at Kay's Home



It takes several men to load the heavy blower/hopper for installing insulation borrowed from Kellogg Lumber Co.



While John Boy Delaney directs the insulation inside the attic, Mike Humphrey and Verne Blalack stuff the bats of insulation into the blower.

After the hose accidently got away from John Boy, slid off the roof and sprayed a shower of insulation around outside, Mike and Verne get the hose back up to him.

We were pleased that there was enough insulation already in the attic that it only took another 6" to bring it up to Verne's "green" standards. Lower heating bills will pay for it and it will feel more comfortable inside.

This insulation project was completed on a Saturday morning and the crew then went on to Krista Kirby's trailer home to work on the skirting. The next Monday after dropping off the blower, we stopped back to vacuum up the last of the insulation that was not easily picked up. Shown here, Mike runs Judy's shop vac.

## Work at Krista Kirby's Home



We were extremely disappointed to find dry rot in the beam behind the facing board we removed to install skirting around the trailer home. Here John Boy holds the end while Mike Humphrey saws the rotted board off.

After the crew levels (sometimes trenching) the ground and measures to fit obstacles, the siding panels are installed. Here Ellie Arguimbau and Krista stain while the temperature is warm enough.

It will probably take another 2 days to finish the work.
